SOURCE A

Democracy

The Northern Ireland government supports democracy. It protects human rights by working with the Northern Ireland Human Rights Commission, Equality Commission and other organisations.

Human rights are important. They help to protect people from abuse. They ensure people are treated equally, are free to express their views and to participate in society.

It is important that young people understand their human rights. Young people can learn about human rights in citizenship classes in school.

The government holds elections and is accountable to the people for decisions taken and its actions. It reaches decisions and passes laws through democratic processes such as debate and voting on issues.

However, some people feel the government does not represent everyone, while others argue that it should be more accountable to the public. While the government supports people's right to march/parade and express their cultural identity, it also has to take into account the human rights of others by sometimes imposing restrictions on marches and parades. Some people view this as an infringement of their human rights.

SOURCE B

Success and pressure

Many young people experience success in school which helps to improve their self-confidence. For example sports clubs, being voted onto a students' council or examination success can make a young person feel good about themselves.

Young people in school may experience pressures such as bullying which may cause them to feel very unhappy in school. A form of bullying is by text messaging. It is important for a young person to talk to a friend, parent or teacher in dealing with text bullying.

Young people may experience pressure from the media such as television and magazines. Celebrities from sport, music and television may have an image which may encourage a young person to diet. There are many dangers of dieting such as developing an eating disorder which may affect a young person's health.

SOURCE C

The Working Environment

When starting up a business, entrepreneurs may experience difficulty with cash flow as they may not have the expertise to cope with all the financial aspects of the business.

Entrepreneurs may have to hire more workers. They may interview various applicants in order to assess their suitability for the job as well as finding out what sort of person they are.

The successful applicants may require training in order to motivate them in their work which could lead to increased sales for the business. However, employees may require time off from their work to participate in training programmes and this may cause problems for the business when meeting deadlines.
