- 4 Photograph A shows construction of an oil pipeline through the Amazon rainforest in Ecuador, an MIC in South America, in 2003.
 - (a) Outline **two** ways in which indigenous people living in the rainforest might be impacted by the construction work, giving evidence from Photograph A. [3]
 - (b) Explain the ways in which the rainforest environment may be at risk of being degraded by construction of the pipeline. [7]
- To what extent do the ideas of sustainability and energy security form part of the electrical energy strategy of **one** country that you have studied? [20]
- With reference to one or more examples, evaluate why it is difficult to improve the quality of a polluted environment. [20]
