EXTRACT B

In the short-term, the impact of Henry's policies on English trade varied. In northern Europe his success was limited; in southern Europe it was greater. There was little change in the pattern of trade between England and the Netherlands, which was the most important destination for English commerce. English merchants were responsible for only a little over half the trade. Foreign merchants had the remainder. But, without Henry's encouragement, the role of English merchants might have been smaller. The long-term effect of his policy was, nevertheless, more important, for he sketched out the lines – into the Baltic and the Mediterranean, and across the Atlantic – along which English commerce was eventually to develop.
