## Source A

From The King's Proclamation of 7 October 1626 calling for the Forced Loan.
We had resolved, for the necessary defence of our honour, our religion, and kingdoms, to require the aid of our loving subjects in the way of a Loan. No other possible and present action can be taken, or this Loan avoided, if we as King are to maintain the cause and party of religion, preserve our own honour, defend our people, secure our kingdoms and support our allies. Nevertheless, we are resolved that this calling for a Loan, which at this time is thus forced upon us by such necessity, shall not in any way become an example, nor made a precedent for after times.

## Source B

From an anonymous pamphlet entitled 'To All English Freeholders from a Well-Wisher of Theirs', 24 January 1627.

Beware and consider what you do concerning this Loan which is now demanded of you, lest you give away not only your money but your liberty and property in your own goods. If this Loan be not withstood, but take effect, we shall be ourselves the means of our own slavery and the loss of the privilege which we have hitherto enjoyed, that our goods cannot be taken from us without the consent of Parliament. Be sure that whatsoever is given for this Loan will be cast away and not dispersed for the good or safety of the Commonwealth but for the private uses and satisfying of the ambitious desires of Favourites.
