Section A

Answer Question 01.

Source A

From an official response from the Soviet Union to the United States, 14 July 1948, following US complaints about the Berlin blockade.

The Soviet government considers that the situation in Berlin has arisen because of the violation by America, Great Britain and France of agreed decisions taken at Potsdam in regard to Germany and Berlin. This violation finds its expression in the introduction of a separate currency and in the policy of the dismemberment of Germany.

The interests of the Berlin population do not permit a situation in which there shall be introduced a currency which has no validity in the Soviet zone. The Soviet Command has been forced, therefore, to adopt certain urgent measures for the protection of the interests of the German population and also of the economy of the Soviet zone of occupation and the area of 'Greater Berlin'.

Source B

From a confidential report on the Berlin blockade, from the British Air Ministry to the British government in 1951.

The Berlin blockade developed as a consequence of decisions made during the war. It was the climax of a planned and deliberate attempt by the Soviets to force the Western allies out of Berlin.

The Potsdam Agreement consisted of a short statement of principle and was not a rule book for the government of Germany. Consequently, co-operation and good faith on the part of the allies was required if effective government of Berlin was to work. Unfortunately, the Soviet attitude prevented this.

The split between the two sectors was made complete by the Allied currency reform introduced in June 1948. This was caused by the Soviets' refusal to co-operate and resulted in each sector having a different currency.
