Within the past week, unmistakable evidence has established the fact that a series of offensive missile sites is now in preparation on Cuba. The purpose of these bases can be none 5 other than to provide a nuclear strike capability against the western hemisphere. This rapid transformation of Cuba into an important strategic base constitutes an explicit threat to 10 the peace and security of all the **Americas.** Neither the United States of America nor the world community of

nations can tolerate deliberatedeception and offensive threats.15Nuclear weapons are so destructiveand ballistic missiles are so swift, thatany substantially increased possibilityof their use or any sudden change intheir deployment may well be regarded 20as a threat to peace.

### SOURCE B

From the memoirs of Nikita Khrushchev, written after he was removed from power in 1964 and published in the West in 1970.

The fate of Cuba and the maintenance of Soviet prestige preoccupied me. We had to establish an effective deterrent to American interference in the Caribbean region. But what 5 exactly? The logical answer was missiles. We knew that American missiles were aimed against us in Turkey, and also in West Germany. I had the idea of installing missiles 10 with nuclear warheads in Cuba without letting the US find out that they were there until it was too late to do anything about them. I want to make one thing absolutely 15 clear; when we put our ballistic missiles in Cuba, we had no desire to

# start a war. On the contrary, our principal aim was to deter America from starting a war.
