Answer **one** question from this Part.

Section 1 – Greek architecture

- 1 Give a broad critical appraisal of either religious or civic Greek architecture, establishing contexts and referring to appropriate architects (where known) and works. [60]

Section 2 – Early Renaissance Italian architecture

- 2 Give a broad critical appraisal of Early Renaissance Italian architecture, establishing contexts and referring to appropriate architects and works. [60]

Section 3 – European architecture Renaissance to Rococo

- 3 Critically appraise two examples of British architecture – by different architects – from the Renaissance to Rococo period, establishing relevant contexts. [60]

Section 4 – Architecture 1835–1918

- 4 Give a broad critical appraisal of architecture 1835–1918, establishing contexts and referring to appropriate movements, architects and works. [60]

Section 5 – Architecture 1900–1945

- 5 Give a broad critical appraisal of architecture 1900–1945, establishing contexts and referring to appropriate movements, architects and works. [60]

Part B

Selected craft and design 1850–1945

Answer **one** question from this Part.

Section 6 – Three-dimensional craft and design 1850–1918

- 6 Which movement* do you consider made the single greatest contribution to three-dimensional craft and design 1850–1918? Establish contexts, refer to appropriate movements, practitioners and works, and give reasons in support of your choice.

*For the purpose of this question, Shaker, Early industrial design, Arts and Crafts Movement and Art Nouveau will all be considered “movements”.

Section 7 – Three-dimensional craft and design 1918–1945

- 7 Three-dimensional craft and design 1918–1945 saw a great variety of design approaches. Compare and contrast the approaches of two craft and/or design practitioners illustrating this diversity, establishing contexts and referring to appropriate works. [60]

Section 8 – Textiles and fashion design 1850–1945

- 8 Textiles and fashion design 1850–1945 saw a great variety of design approaches. Discuss the approaches of three textiles and/or fashion designers illustrating this diversity, establishing contexts and referring to appropriate works. [60]

Section 9 – Graphic design 1850–1945

- 9 The pursuit of pleasure and the pursuit of victory were major motivations behind graphic design 1850–1945. Discuss, establishing contexts and referring to appropriate movements, designers and works. [60]

Section 10 – Automotive design to 1945

- 10 Automotive design to 1945 saw very different design approaches. Compare and contrast the approaches of two designers/manufacturers illustrating this diversity, establishing contexts and referring to appropriate examples. [60]
