2 Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Please also see under 'General Apparatus' on the use of pipette fillers and safety goggles.

In accordance with COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

Attention is drawn, in particular, to certain materials used in the examination. The following codes are used where relevant.

**C** = corrosive substance

**F** = highly flammable substance

**H** = harmful or irritating substance

**O** = oxidising substance

T = toxic substance

#### **General Apparatus**

- 1 In addition to the fittings and reagents ordinarily contained in a chemical laboratory, the apparatus and materials specified below will be necessary.
- 2 It as assumed that bench solutions (2 mol dm<sup>-3</sup> concentration, 1 mol dm<sup>-3</sup> for sulphuric acid) of the common acids and alkalis are available.
- 3 Pipette fillers and safety goggles should be used where necessary.

For each candidate

a foamed plastic (polystyrene) cup

a 250 cm<sup>3</sup> beaker

2 50 cm<sup>3</sup> measuring cylinders

a -10°C to 110°C thermometer by 1°C

access to a balance weighing to 0.01 g or better – in centres with limited access to balances some candidates should be instructed to start on question 2

a weighing bottle

a spatula

a teat pipette

test-tubes for question 2

#### Particular requirements

- 1 As a possible aid to maintaining security, the descriptions of the particular chemicals required are given under two headings:
  - (a) overall specifications are given on page 3;
  - **(b)** the actual identities are given on page 4.
- 2 Materials with an **FB** code number should be so labelled for the candidates' benefit, **without** the identities being included on the label where appropriate, the identity of an **FB** coded chemical is given in the question paper itself.

#### **Chemicals Required**

- 1 The chemicals required per question are described in general terms below.
- www.PapaCambridge.com 2 Where quantities are specified for each candidate (shown after a colon against each listed iter they are meant as guides only and are quantities greater than candidates will normally need to use. It is suggested that about 80% of the specified quantities should be distributed to candidates with the remainder kept as a central reserve. More material may be supplied if requested by candidates, without penalty.

Where relevant, spare material should be available to cover accidental loss.

#### **Detailed Identities of Chemicals Required**

- 2 The identities of the chemicals with an **FB** code number are as follows.

Liquids

#### **Question 1**

- **FB 1** is 2.00 mol dm<sup>-3</sup> hydrochloric acid. [H]
- [H] FB 2 is sodium carbonate provided in a stoppered tube, labelled Tube 1.
  - FB 3 is sodium hydrogen carbonate provided in a stoppered tube, labelled Tube 2.
  - FB 4 is solid sodium carbonate.

These should be provided in stoppered containers to prevent absorption of moisture.

#### **Question 2**

- **FB 5** is 0.10 mol dm<sup>-3</sup> zinc nitrate, containing 29.7 g dm<sup>-3</sup> of Zn(NO<sub>3</sub>)<sub>2</sub>.6H<sub>2</sub>O. [H] [O]
- **FB 6** is 0.10 mol dm<sup>-3</sup> aluminium nitrate, containing 37.5 g dm<sup>-3</sup> of Al(NO<sub>3</sub>)<sub>3</sub>.9H<sub>2</sub>O. [H] [O]
- FB 7 is 0.10 mol dm<sup>-3</sup> lead nitrate, containing 33.1 g dm<sup>-3</sup> of Pb(NO<sub>3</sub>)<sub>2</sub>. [T] [O]

Normal reagents for the identification of the cations given in the qualitative analysis notes are required.

#### **COLOUR BLINDNESS**

www.PapaCambridge.com With regard to colour-blindness - a minor handicap, relatively common in males - it is permit advise candidates who request assistance on colours of, for example, precipitates and solu-(especially titration end-points). Please include with the scripts a note of the index numbers of su candidates.

Experience suggests that candidates who are red/green colour-blind – the most common form – do not generally have significant difficulty. Reporting such cases with the scripts removes the need for a 'Special Consideration' application for this handicap.

### **Accuracy of Solutions**

1 All the solutions are to be labelled as shown and they should each be bulked and mixed thoroughly before use to ensure uniformity.

Every effort should be made to keep the concentrations accurate within one part in two hundred of those specified.

If the concentrations differ slightly from those specified, the Examiners will make the necessary allowance. They should be informed of the exact concentrations.

- 2 It should also be noted that descriptions of solutions given in the question paper may not correspond exactly with the specification in these Instructions. The candidates must assume the descriptions given in the question paper.
- 3 In view of the difficulty of the preparation of large quantities of solution of uniform concentration, it is recommended that the maximum number of candidates per group be 30 and that separate supplies of solutions be prepared for each group.

#### Responsibilities of the Supervisor

- www.PapaCambridge.com (i) The Supervisor, or other competent chemist must carry out the experiments in que and complete the tables of readings on a spare copy of the question paper which should labelled 'Supervisor's Results'. This should be done for each session held and for each set solutions supplied. It is essential that each packet of scripts contains a copy of the Supervisor's Results as the candidates' work cannot be assessed accurately without such information.
- (ii) The Supervisor must complete the Report Form on page 7 to show which candidates attended each session. If all candidates took the examination in one session, please indicate this on the Report Form. A copy of the Report Form must accompany each copy of the Supervisor's Results in order for the candidates' work to be assessed accurately.
- The Supervisor must give details on page 8 of any particular difficulties experienced by a candidate, especially if the Examiner would be unable to discover this from the written answers.
