1 Either (a) What in your view does Shakespeare's presentation of ideas about acting and actors contribute to the play's meaning and effects?

Or (b) Paying close attention to the language, tone and action, write a critical appreciation of the following passage, showing what it reveals about Claudius and Hamlet at this point in the play.

King: $\quad \mathrm{O}$, my offence is rank, it smells to heaven; It hath the primal eldest curse upon't A brother's murder! Pray can I not, Though inclination be as sharp as will. My stronger guilt defeats my strong intent, And, like a man to double business bound, I stand in pause where I shall first begin, And both neglect. What if this cursed hand Were thicker than itself with brother's blood, Is there not rain enough in the sweet heavens To wash it white as snow? Whereto serves mercy But to confront the visage of offence? And what's in prayer but this twofold force, To be forestalled ere we come to fall, Or pardon'd being down? Then l'll look up; 15 My fault is past. But, O, what form of prayer Can serve my turn? 'Forgive me my foul murder'! That cannot be; since I am still possess'd Of those effects for which I did the murder My crown, mine own ambition, and my queen. May one be pardon'd and retain th' offence? In the corrupted currents of this world Offence's gilded hand may shove by justice; And oft 'tis seen the wicked prize itself Buys out the law. But 'tis not so above:
There is no shuffling; there the action lies In his true nature; and we ourselves compell'd, Even to the teeth and forehead of our faults, To give in evidence. What then? What rests? Try what repentance can. What can it not?
Yet what can it when one can not repent?
O wretched state! O bosom black as death!
O limed soul, that, struggling to be free,
Art more engag'd! Help, angels. Make assay: Bow, stubborn knees; and, heart, with strings of steel, Be soft as sinews of the new-born babe.
All may be well.
[Retires and kneels.

She would not stir farther from the east-room than the head of the great staircase, till she had satisfied herself of Mr Crawford's having left the house; but when convinced of his being gone, she was eager to go down and be with her uncle, and have all the happiness of his joy as well as her own, and all the benefit of his information or his conjectures as to what would now be William's destination. Sir Thomas was as joyful as she could desire, and very kind and communicative; and she had so comfortable a talk with him about William as to make her feel as if nothing had occurred to vex her, till she found towards the close that Mr Crawford was engaged to return and dine there that very day. This was a most unwelcome hearing, for though he might think nothing of what had passed, it would be quite distressing to her to see him again so soon.

She tried to get the better of it, tried very hard as the dinner hour approached, to feel and appear as usual; but it was quite impossible for her not to look most shy and uncomfortable when their visitor entered the room. She could not have supposed it in the power of any concurrence of circumstances to give her so many painful sensations on the first day of hearing of William's promotion.

Mr Crawford was not only in the room; he was soon close to her. He had a note to deliver from his sister. Fanny could not look at him, but there was no consciousness of past folly in his voice. She opened her note immediately, glad to have any thing to do, and happy, as she read it, to feel that the fidgettings of her aunt Norris, who was also to dine there, screened her a little from view.
'MY DEAR FANNY, for so I may always call you, to the infinite relief of a tongue that has been stumbling at Miss Price for at least the last six weeks - I cannot let my brother go without sending you a few lines of general congratulation, and giving my most joyful consent and approval. - Go on, my dear Fanny, and without fear; there can be no difficulties worth naming. I chuse to suppose that the assurance of my consent will be something; so, you may smile upon him with your sweetest smiles this afternoon, and send him back to me even happier than he goes.

Yours affectionately,
These were not expressions to do Fanny any good; for though she read in too much haste and confusion to form the clearest judgment of Miss Crawford's meaning, it was evident that she meant to compliment her on her brother's attachment and even to appear to believe it serious. She did not know what to do, or what to think. There was wretchedness in the idea of its being serious; there was perplexity and agitation every way. She was distressed whenever Mr Crawford spoke to her, and he spoke to her much too often; and she was afraid there was a something in his voice and manner in addressing her, very different from what they were when he talked to the others. Her comfort in that day's dinner was quite destroyed; she could hardly eat any thing; and when Sir Thomas good humouredly observed, that joy had taken away her appetite, she was ready to sink with shame, from the dread of Mr Crawford's interpretation; for though nothing could have tempted her to turn her eyes to the right hand where he sat, she felt that his were immediately directed towards her.

Or (b) Paying close attention to language and tone, write a critical appreciation of following passage, showing its significance to the novel as a whole.
"Mr. Harthouse," returned Sissy, with a blending of gentleness and steadiness that quite defeated him, and with a simple confidence in his being bound to do what she required, that held him at a singular disadvantage, "the only reparation that remains with you, is to leave here immediately and finally. I am quite sure that you can mitigate in no other way the wrong and harm you have done. I am quite sure that it is the only compensation you have left it in your power to make. I do not say that it is much, or that it is enough; but it is something, and it is necessary. Therefore, though without any other authority than I have given you, and even without the knowledge of any other person than yourself, I ask you to depart from this place to-night, under an obligation never to return to it."

'I don't know - some poor woman's who has been found in the snow, I believe,' was the answer Godfrey wrung from himself with a terrible effort. ('After all, am I certain?' he hastened to add, in anticipation of his own conscience.)
'Why, you'd better leave the child here, then, Master Marner,' said good-natured Mrs Kimble, hesitating, however, to take those dingy clothes into contact with her own ornamented satin boddice. 'l'll tell one o' the girls to fetch it.'
