	building earth dams: allows rainwater to be retained; increases soil moisture content locally; allows for irrigation of crops;	
	fencing: allows grazing to be controlled; reduces soil erosion; controls compaction;	
	applying green manure: improves soil structure; soil fertility; prevents erosion when land would be fallow;

	analysis of gas: monitoring emissions of sulphur dioxide, increased emissions are likely to suggest increased activity.	
	measuring ground deformation: bulging of mountain, can suggest increased activity and hint at potentially dangerous eruptions from new vents.	
	using remote sensing imagery: to reveal ash / steam cloud activity / thermal sensing reveals activity, and is safer for the observers.	
	taking geophysical measurements: hydrological changes from groundwater sampling, e.g. loss of water from aquifer / muddy / turbidity changes to the water
