#### 1 Study Documents A and B.

Identify **two** cities that have had a reduction in travel times, as given by the author of Document A. [2]

(b) The authors of Document B discuss the growing problem of traffic congestion in African cities.

Identify **three** negative consequences of traffic congestion in cities, as given by the authors of Document B. [3]

### 2 Study Document A.

Assess the strengths and weaknesses of the evidence used by the author of Document A to support their argument that artificial intelligence technology can solve traffic congestion problems.

In your answer, include the impact of the evidence on the author's argument. [15]

#### 3 Study Documents A and B.

The authors of both documents present different arguments and perspectives about ways to reduce traffic congestion in cities.

Evaluate the arguments of the authors of both documents. In your answer, consider their perspectives and include a reasoned judgement about whether one argument is stronger than the other. [25]
