1 Verify that

$$\frac{1}{n^2 + 1} - \frac{1}{(n + 1)^2 + 1} = \frac{2n + 1}{(n^2 + 1)(n^2 + 2n + 2)}.$$

Use the method of differences to show that, for all $N \geq 1$,

$$\sum_{n=1}^N \frac{2n + 1}{(n^2 + 1)(n^2 + 2n + 2)} < \frac{1}{2}. \quad [3]$$

Write down the value of

$$\sum_{n=1}^{\infty} \frac{2n + 1}{(n^2 + 1)(n^2 + 2n + 2)}. \quad [1]$$

2 The curve C is defined parametrically by

$$x = t - \ln t, \quad y = 4t^{\frac{1}{2}},$$

where $t > 0$. The arc of C joining the point where $t = 1$ to the point where $t = 4$ is rotated through one complete revolution about the x -axis. Show that the area of the surface generated is $\frac{160}{3}\pi$. [6]

3 Find the general solution of the differential equation

$$\frac{d^2y}{dx^2} + 4\frac{dy}{dx} + 29y = 58x + 37. \quad [6]$$

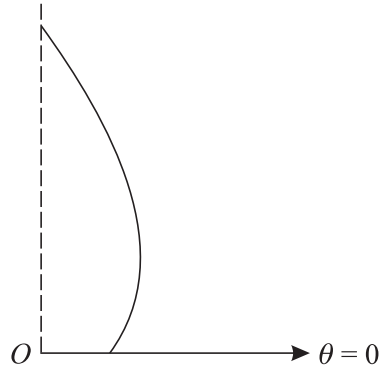
4 Given that the variables x and y are related by

$$y = x + e^{-xy},$$

find the value of $\frac{d^2y}{dx^2}$ when $x = 0$.

The diagram shows the curve C with polar equation $r = e^\theta$, where $0 \leq \theta \leq \frac{1}{2}\pi$. Find the maximum distance of a point of C from the line $\theta = \frac{1}{2}\pi$, giving the answer in exact form. [4]

Find the area of the finite region bounded by C and the lines $\theta = 0$ and $\theta = \frac{1}{2}\pi$, giving the answer in exact form. [3]

6 The matrix \mathbf{A} , given by

$$\mathbf{A} = \begin{pmatrix} 7 & -4 & 6 \\ 2 & 2 & 2 \\ -3 & 4 & -2 \end{pmatrix},$$

has eigenvalues 1, 2, 4. Find a set of corresponding eigenvectors. [4]

Hence find the eigenvalues of \mathbf{B} , where

$$\mathbf{B} = \begin{pmatrix} 10 & -4 & 6 \\ 2 & 5 & 2 \\ -3 & 4 & 1 \end{pmatrix},$$

and state a set of corresponding eigenvectors. [3]

7 The equation

$$x^3 + 3x - 1 = 0$$

has roots α, β, γ . Use the substitution $y = x^3$ to show that the equation whose roots are $\alpha^3, \beta^3, \gamma^3$ is

$$y^3 - 3y^2 + 30y - 1 = 0. \quad [2]$$

Find the value of $\alpha^9 + \beta^9 + \gamma^9$. [5]

8 The sequence x_1, x_2, x_3, \dots is such that $x_1 = 1$ and

$$x_{n+1} = \frac{1 + 4x_n}{5 + 2x_n}.$$

Prove by induction that $x_n > \frac{1}{2}$ for all $n \geq 1$. [5]

Prove also that $x_n > x_{n+1}$ for all $n \geq 1$. [3]

9 Let

$$I_n = \int_0^1 \frac{1}{(4-x^2)^n} dx,$$

for $n = 1, 2, 3, \dots$. Verify that

$$\frac{d}{dx} \left[\frac{x}{(4-x^2)^n} \right] = \frac{1-2n}{(4-x^2)^n} + \frac{8n}{(4-x^2)^{n+1}}$$

and hence prove that

$$8nI_{n+1} = (2n-1)I_n + \frac{1}{3^n}. \quad [5]$$

Find the y -coordinate of the centroid of the region bounded by the axes, the line $x = 1$ and the curve

$$y = \frac{1}{4-x^2},$$

giving your answer correct to 3 decimal places. [5]

10 The line l_1 passes through the points P and Q whose position vectors are $\mathbf{i} - \mathbf{j} - 2\mathbf{k}$ and $-2\mathbf{i} + 5\mathbf{j} + 13\mathbf{k}$ respectively. The line l_2 passes through the point S whose position vector is $\mathbf{i} - 2\mathbf{j} + 8\mathbf{k}$ and is parallel to the vector $\mathbf{i} - \mathbf{j} - 3\mathbf{k}$. The point whose position vector is $-\mathbf{i} + 3\mathbf{j} + 2\mathbf{k}$ is on the line l_3 , the common perpendicular to l_1 and l_2 .

(i) Find, in the form $\mathbf{r} = \mathbf{a} + t\mathbf{b}$, an equation for l_3 . [3]

(ii) Find the perpendicular distance from S to l_3 . [4]

(iii) Find the perpendicular distance from S to the plane which contains l_3 and passes through P . [4]

11 (a) Use de Moivre's theorem to show that $\sin 8\theta$ can be expressed in the form

$$\sin \theta \cos \theta (a \sin^6 \theta + b \sin^4 \theta + c \sin^2 \theta + d),$$

where the value of the constant a is to be found and b, c, d are constants whose values need not be found. [6]

(b) Use de Moivre's theorem to show that

$$\sum_{n=1}^N \frac{\sin n\theta}{2^n} = \frac{2^{N+1} \sin \theta + \sin N\theta - 2 \sin(N+1)\theta}{2^N(5-4 \cos \theta)}. \quad [7]$$

12 Answer only **one** of the following two alternatives.

EITHER

The curve C has equation

$$y = \lambda x + \frac{x}{x+2},$$

where λ is a non-zero constant.

- (i) Find the asymptotes of C . [3]
- (ii) Show that if $\lambda > 0$ then $\frac{dy}{dx} > 0$ at all points of C . [2]
- (iii) Show that, for $\lambda < -\frac{1}{2}$, C has two distinct stationary points, both to the left of the y -axis. [3]
- (iv) In separate diagrams draw sketches of C for each of the cases $\lambda > 0$ and $\lambda < -\frac{1}{2}$. [6]

OR

The linear transformation $T : \mathbb{R}^4 \rightarrow \mathbb{R}^4$ is represented by the matrix

$$\mathbf{M} = \begin{pmatrix} 1 & -2 & 2 & 4 \\ 2 & -4 & 5 & 9 \\ 3 & -6 & 8 & 14 \\ 5 & -10 & 12 & 22 \end{pmatrix}.$$

- (i) Find the rank of \mathbf{M} . [3]
- (ii) Obtain a basis for the null space, K , of T . [3]
- (iii) Evaluate

$$\mathbf{M} \begin{pmatrix} -1 \\ 2 \\ -3 \\ 4 \end{pmatrix},$$

and hence show that any solution of

$$\mathbf{M}\mathbf{x} = \begin{pmatrix} 5 \\ 11 \\ 17 \\ 27 \end{pmatrix} \quad (*)$$

has the form

$$\begin{pmatrix} -1 \\ 2 \\ -3 \\ 4 \end{pmatrix} + \lambda \mathbf{e}_1 + \mu \mathbf{e}_2,$$

where λ and μ are constants and $\{\mathbf{e}_1, \mathbf{e}_2\}$ is a basis for K . [3]

- (iv) Find the solution \mathbf{x}_1 of (*) such that the first component of \mathbf{x}_1 is A , and the sum of all the components of \mathbf{x}_1 is B . [5]
