- 1 The roots of the cubic equation $x^3 - 7x^2 + 2x - 3 = 0$ are α, β, γ . Find the values of

(i) $\alpha^2 + \beta^2 + \gamma^2$,

(ii) $\alpha^3 + \beta^3 + \gamma^3$.

- 2 Prove, by mathematical induction, that, for integers $n \geq 2$,

$$4^n > 2^n + 3^n. \quad [5]$$

- 3 Given that $f(r) = \frac{1}{(r+1)(r+2)}$, show that

$$f(r-1) - f(r) = \frac{2}{r(r+1)(r+2)}. \quad [2]$$

Hence find $\sum_{r=1}^n \frac{1}{r(r+1)(r+2)}$. [3]

Deduce the value of $\sum_{r=1}^{\infty} \frac{1}{r(r+1)(r+2)}$. [1]

- 4 The curve C has polar equation $r = 2 + 2 \cos \theta$, for $0 \leq \theta \leq \pi$. Sketch the graph of C . [2]

Find the area of the region R enclosed by C and the initial line. [4]

The half-line $\theta = \frac{1}{5}\pi$ divides R into two parts. Find the area of each part, correct to 3 decimal places. [3]

- 5 A matrix \mathbf{A} has eigenvalues $-1, 1$ and 2 , with corresponding eigenvectors

$$\begin{pmatrix} 0 \\ 1 \\ -2 \end{pmatrix}, \quad \begin{pmatrix} -1 \\ -1 \\ 3 \end{pmatrix} \quad \text{and} \quad \begin{pmatrix} 2 \\ -3 \\ 5 \end{pmatrix},$$

respectively. Find \mathbf{A} . [9]

- 6 Write down the values of θ , in the interval $0 \leq \theta < 2\pi$, for which $\cos \theta + i \sin \theta$ is a fifth root of unity. [2]

By writing the equation $(z+1)^5 = z^5$ in the form

$$\left(\frac{z+1}{z}\right)^5 = 1,$$

show that its roots are

$$-\frac{1}{2} \left\{ 1 + i \cot\left(\frac{k\pi}{5}\right) \right\}, \quad k = 1, 2, 3, 4. \quad [7]$$

- 7 The linear transformations $T_1 : \mathbb{R}^4 \rightarrow \mathbb{R}^4$ and $T_2 : \mathbb{R}^4 \rightarrow \mathbb{R}^4$ are represented by the matrices

$$\mathbf{M}_1 = \begin{pmatrix} 1 & 1 & 1 & 4 \\ 2 & 1 & 4 & 11 \\ 3 & 4 & 1 & 9 \\ 4 & -3 & 18 & 37 \end{pmatrix} \quad \text{and} \quad \mathbf{M}_2 = \begin{pmatrix} 1 & 1 & 1 & -1 \\ 2 & 3 & 0 & 1 \\ 3 & 4 & 1 & 0 \\ 4 & 5 & 2 & 0 \end{pmatrix},$$

respectively. The null space of T_1 is denoted by K_1 and the null space of T_2 is denoted by K_2 . Show that the dimension of K_1 is 2 and that the dimension of K_2 is 1. [5]

Find the basis of K_1 which has the form $\left\{ \begin{pmatrix} p \\ q \\ 1 \\ 0 \end{pmatrix}, \begin{pmatrix} r \\ s \\ 0 \\ 1 \end{pmatrix} \right\}$ and show that K_2 is a subspace of K_1 . [5]

- 8 Find the particular solution of the differential equation

$$\frac{d^2y}{dx^2} + 2\frac{dy}{dx} + 5y = 10e^{-2x},$$

given that $y = 5$ and $\frac{dy}{dx} = 1$ when $x = 0$. [11]

- 9 The curve C has equation

$$y = \frac{2x^2 + 2x + 3}{x^2 + 2}.$$

Show that, for all x , $1 \leq y \leq \frac{5}{2}$. [4]

Find the coordinates of the turning points on C . [3]

Find the equation of the asymptote of C . [2]

Sketch the graph of C , stating the coordinates of any intersections with the y -axis and the asymptote. [2]

- 10 The curve C has equation

$$y = 2\left(\frac{x}{3}\right)^{\frac{3}{2}},$$

where $0 \leq x \leq 3$. Show that the arc length of C is $2(2\sqrt{2} - 1)$. [4]

Find the coordinates of the centroid of the region enclosed by C , the x -axis and the line $x = 3$. [7]

11 Answer only **one** of the following two alternatives.

EITHER

Show that

$$\int_0^{\pi} e^x \sin x \, dx = \frac{1 + e^{\pi}}{2}. \quad [4]$$

Given that

$$I_n = \int_0^{\pi} e^x \sin^n x \, dx,$$

show that, for $n \geq 2$,

$$I_n = n(n-1) \int_0^{\pi} e^x \cos^2 x \sin^{n-2} x \, dx - nI_n,$$

and deduce that

$$(n^2 + 1)I_n = n(n-1)I_{n-2}. \quad [6]$$

A curve has equation $y = e^x \sin^5 x$. Find, in an exact form, the mean value of y over the interval $0 \leq x \leq \pi$. [4]

OR

The position vectors of the points A, B, C, D are

$$2\mathbf{i} + 4\mathbf{j} - 3\mathbf{k}, \quad -2\mathbf{i} + 5\mathbf{j} - 4\mathbf{k}, \quad \mathbf{i} + 4\mathbf{j} + \mathbf{k}, \quad \mathbf{i} + 5\mathbf{j} + m\mathbf{k},$$

respectively, where m is an integer. It is given that the shortest distance between the line through A and B and the line through C and D is 3. Show that the only possible value of m is 2. [7]

Find the shortest distance of D from the line through A and C . [3]

Show that the acute angle between the planes ACD and BCD is $\cos^{-1}\left(\frac{1}{\sqrt{3}}\right)$. [4]
