## General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

## Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

#### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

## **During the exam**

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
  This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

The supervisor must be a teacher of physics or other competent physicist who is familiar with the requirements of this syllabus. During the exam, the supervisor (**not** the invigilator) should obtain a sample set of numerical results by following the relevant steps in the question paper. The results should be clearly labelled 'supervisor's results' and recorded on the supervisor's report or on a spare copy of the question paper.

## Organisation of the exam

- The number of sets of apparatus provided for each experiment should be  $\frac{1}{2}N$ , where N is the number of candidates taking the exam.
- Candidates must **not** be provided with any additional apparatus beyond that specified in these instructions.
- Candidates should be allowed access to the apparatus for each experiment for one hour only.
- After spending one hour on one experiment, candidates should change over to the other experiment.
- The order in which a candidate attempts the two experiments is immaterial.

#### Assistance to candidates

- Candidates should be informed that, if they find themselves in real difficulty, they may ask the supervisor for practical assistance, but that the extent of this assistance will be reported to the examiner, who may not award full credit for the relevant skills.
- Assistance should only be given when it is asked for by a candidate or where apparatus is seen to have developed a fault.
- Assistance should be restricted to enabling candidates to make observations and measurements.
  Observations and measurements must **not** be made for candidates, and no help should be given with data analysis or evaluation.
- In cases of faulty apparatus that prevent the required measurements from being taken, the supervisor should allow extra time to give the candidate a fair opportunity to perform the experiment as if the fault had not been present.
- Any assistance or extra time given to candidates must be recorded in the supervisor's report.

#### Materials and apparatus for Question 1 (per set of apparatus unless otherwise specified)

- Wooden strip of length 48.0 cm and approximate cross-section 0.5 cm x 2 cm. See Note 1.
- Triangular wooden or glass prism of height in the range 1–5 cm suitable for use as a pivot.
- Three 50 g slotted masses with their mass values clearly shown. See Note 1.
- Four 10 g slotted masses with their mass values clearly shown.
- Two M5 nuts and bolts of length 40 mm. They are used to secure slotted masses to the strip, so a smaller diameter should be provided if the holes in the slotted masses are less than 5 mm diameter. See Note 1.
- Stand of height at least 60 cm.
- Boss and clamp.
- Nail of approximate diameter 3 mm and approximate length 6 cm.
- Split cork for holding the nail securely in the clamp.
- Stop-watch reading to 0.1s or better.
- 30 cm ruler with a millimetre scale.

#### **Notes**




Fig. 1.1 (not to scale)

1 Three holes each of diameter 5.0 mm should be drilled through the strip at the positions A, B and C shown in Fig. 1.1.




Fig. 1.2 (not to scale)

Fix two of the 50 g masses, one either side of the strip, using a nut and bolt through hole C, as shown in Fig. 1.2.

The other nut and bolt should be laid on the bench.

**2** The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state.

#### Materials and apparatus for Question 2 (per set of apparatus unless otherwise specified)

- Wooden strip of length 45.0 cm with approximate cross-section 5 mm x 12 mm. See Note 1 and Note 2.
- Paper clip bent into a hook shape. See Note 1.
- Stand, boss and clamp. See Note 2.
- Cork. See Note 2.
- Optical pin (e.g. Timstar product code OP11788). See Note 2.
- Plastic water pipe with external diameter 15 mm (e.g. www.toolstation.com product code 52801).
  See Note 3.
- Thin string. See Note 3.
- 250 cm<sup>3</sup> measuring cylinder of approximate height 32 cm.
- 50 g slotted mass on a 50 g mass hanger. The mass and hanger must be small enough to fit inside the measuring cylinder.
- Metre rule with a millimetre scale.
- Access to an electric kettle, sink and water supply (may be shared between candidates). See Note 4.
- Thermometer with range –10 °C to 110 °C reading to 1 °C.
- Paper towels to mop up any spillages.

#### Notes

1 The wooden strip should have two holes each of diameter 2 mm drilled through it in the positions shown in Fig. 2.1. The paper clip should be passed through the hole nearest the end and bent into a hook.



2 Assemble the stand, boss, clamp, cork, pin and wooden strip as shown in Fig. 2.2. The strip should pivot freely when the end is lifted from the bench.



3 Two lengths of plastic pipe should be provided, one of length 12.2 cm and one of length 7.4 cm. A hole of diameter 2 mm should be drilled all the way through each pipe at a distance of 0.5 cm from each end. String loops should be tied through the holes as shown in Fig. 2.3.



- The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state.
