It does not indicate the details of the discussions that took place at an Examiners' meeting before marking began, which would have considered the acceptability of alternative answers.

Mark schemes should be read in conjunction with the question paper and the Principal Examiner Report for Teachers.

Cambridge International will not enter into discussions about these mark schemes.

Cambridge International is publishing the mark schemes for the October/November 2023 series for most Cambridge IGCSE, Cambridge International A and AS Level components, and some Cambridge O Level components.

### **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

### GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

### **GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always whole marks (not half marks, or other fractions).

### **GENERIC MARKING PRINCIPLE 3:**

### Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit
  is given for valid answers which go beyond the scope of the syllabus and mark scheme,
  referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these
  features are specifically assessed by the question as indicated by the mark scheme. The
  meaning, however, should be unambiguous.

### **GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

### **GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

### GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

# Social Science-Specific Marking Principles (for point-based marking)

### 1 Components using point-based marking:

Point marking is often used to reward knowledge, understanding and application of skills.
 We give credit where the candidate's answer shows relevant knowledge, understanding and application of skills in answering the question. We do not give credit where the answer shows confusion.

### From this it follows that we:

- **a** DO credit answers which are worded differently from the mark scheme if they clearly convey the same meaning (unless the mark scheme requires a specific term)
- b DO credit alternative answers/examples which are not written in the mark scheme if they are correct
- **c** DO credit answers where candidates give more than one correct answer in one prompt/numbered/scaffolded space where extended writing is required rather than list-type answers. For example, questions that require *n* reasons (e.g. State two reasons ...).
- **d** DO NOT credit answers simply for using a 'key term' unless that is all that is required. (Check for evidence it is understood and not used wrongly.)
- **e** DO NOT credit answers which are obviously self-contradicting or trying to cover all possibilities
- f DO NOT give further credit for what is effectively repetition of a correct point already credited unless the language itself is being tested. This applies equally to 'mirror statements' (i.e. polluted/not polluted).
- **g** DO NOT require spellings to be correct, unless this is part of the test. However spellings of syllabus terms must allow for clear and unambiguous separation from other syllabus terms with which they may be confused (e.g. Corrasion/Corrosion)

### 2 Presentation of mark scheme:

- Slashes (/) or the word 'or' separate alternative ways of making the same point.
- Semi colons (;) bullet points (•) or figures in brackets (1) separate different points.
- Content in the answer column in brackets is for examiner information/context to clarify the marking but is not required to earn the mark (except Accounting syllabuses where they indicate negative numbers).

### 3 Calculation questions:

- The mark scheme will show the steps in the most likely correct method(s), the mark for each step, the correct answer(s) and the mark for each answer
- If working/explanation is considered essential for full credit, this will be indicated in the question paper and in the mark scheme. In all other instances, the correct answer to a calculation should be given full credit, even if no supporting working is shown.
- Where the candidate uses a valid method which is not covered by the mark scheme, award equivalent marks for reaching equivalent stages.
- Where an answer makes use of a candidate's own incorrect figure from previous working, the 'own figure rule' applies: full marks will be given if a correct and complete method is used. Further guidance will be included in the mark scheme where necessary and any exceptions to this general principle will be noted.

### 4 Annotation:

- For point marking, ticks can be used to indicate correct answers and crosses can be used to indicate wrong answers. There is no direct relationship between ticks and marks. Ticks have no defined meaning for levels of response marking.
- For levels of response marking, the level awarded should be annotated on the script.
- Other annotations will be used by examiners as agreed during standardisation, and the meaning will be understood by all examiners who marked that paper.

### Using the mark scheme

Some of the questions are marked using a point-based system, awarding marks for specific points and accumulating a total mark by adding points.

Some of the questions are marked using level of response. For these, the level descriptor represents performance at the top of the level.

For levels of response marking you should:

- award a mark at the top of the level if all criteria in the level are met
- consider the level descriptors across the full range, bearing in mind that it is not necessary for a candidate to give a faultless performance for maximum marks to be awarded within any single category
- award marks on a 'best-fit' basis; thus, compensation between higher and lower achievement for different criteria is acceptable

When marking holistically, the marks awarded for an answer are usually based on a judgement of the overall quality of the response. For holistic marking, inevitably, the mark scheme cannot cover all responses that candidates may make for all of the questions. In some cases, candidates may make some responses which the mark scheme has not predicted. These answers should nevertheless be credited according to their quality.

	Indicative content	
	<ul> <li>Lack of male role models.</li> <li>Methods of study and assessment, e.g. coursework suits girls.</li> <li>Teachers expect boys to be lazy, disruptive, leading to lower expectations or boys' overconfidence / teachers' high expectations of girls as hard working, obedient, etc.</li> <li>Feminisation of education.</li> <li>Positive discrimination policies have focused on girls' achievements.</li> <li>Male anti-school subcultures.</li> <li>Crisis of masculinity; confused self-image in relation to subject choices and careers.</li> <li>Gendered curriculum leading to less encouragement for boys in some subjects.</li> <li>Any other relevant reason.</li> <li>Reward a maximum of two reasons. Up to 4 marks are available for each reason:</li> <li>1 mark for making a point / giving a reason. (e.g. Lack of male role models).</li> <li>1 mark for explaining that point (e.g. If there are few male teachers in school, boys may feel estranged/uninspired)</li> <li>1 mark for selecting relevant sociological material such as a study/concept/theory/empirical evidence to support the point (e.g. DfE statistics)</li> <li>1 mark for explaining how the material supports the point (e.g. 14% of primary school teachers in UK are male. 31% of 8–11-year-old boys have no male teacher.)</li> </ul>

	Indicative content	
	<ul> <li>Low attaining ethnic groups usually have lower economic class position which is more likely to explain this variation.</li> <li>Institutional racism throughout society can affect opportunities and aspirations of some ethnic groups.</li> <li>Media representations of ethnicity can affect identity and attainment.</li> <li>Ethnocentric curriculum favours attainment for some more than others.</li> <li>Role models in school structures may not be ethnically diverse.</li> <li>Classroom interaction may be influenced by teachers' ethnic stereotypes – labelling and self-fulfilling prophecy.</li> <li>Setting, streaming, subject and career guidance, discipline and exclusions affected by perceptions of ethnicity.</li> <li>Any other relevant argument against this view.</li> <li>Reward a maximum of two arguments. Up to 6 marks are available for each argument.</li> <li>Note: This question is asking for arguments against the view. There are no marks for explaining the view or giving arguments supporting the view.</li> <li>Levels of response</li> <li>Use the following levels to mark each argument.</li> <li>Level 3: 5–6 marks</li> <li>One clear and developed argument against the view that lower educational attainment of some ethnic groups is due to the culture of those ethnic groups. Sociological material, such as concepts, theories and evidence, is used to support the argument against the view. The material selected is appropriate and focused on the question with its relevance made clear.</li> <li>Level 2: 3–4 marks</li> </ul>	
	<ul> <li>One clear but underdeveloped argument against the view that lower educational attainment of some ethnic groups is due to the culture of those ethnic groups.</li> <li>The material selected is appropriate but not fully focused on the question. Sociological evidence is used but its relevance to the argument is not made clear.</li> </ul>	
	<ul> <li>Level 1: 1–2 marks</li> <li>One point disagreeing with the view that lower educational attainment of some ethnic groups is due to the culture of those ethnic groups which is undeveloped or lacking clarity.</li> <li>Any material selected lacks focus on the specific question.</li> </ul>
