## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates

## Specific information for this practical exam

### Materials and apparatus for Question 2

Each candidate will require the following materials and apparatus. Labels do **not** need to include concentrations.

[MH]	stoppered boiling tube containing a homogeneous mixture of solid ammonium sulfate and potassium chromium(III) sulfate dodecahydrate (chrome alum), $\text{KCr}(\text{SO}_4)_2 \cdot 12\text{H}_2\text{O}$ , in a 1:2 ratio by mass. The mixture should be ground using a pestle and mortar to break up the large crystals.	2g	E
	aqueous sodium hydrogencarbonate of concentration $1 \text{ mol/dm}^3$	$10 \text{ cm}^3$	
[MH]	acidified aqueous potassium manganate(VII) This can be prepared by making a $0.01 \text{ mol/dm}^3$ solution of $\text{KMnO}_4$ using $0.5 \text{ mol/dm}^3$ dilute sulfuric acid as the solvent.		
[C]	dilute nitric acid of concentration $1 \text{ mol/dm}^3$		
[C]	aqueous sodium hydroxide of concentration $1 \text{ mol/dm}^3$		
	aqueous barium nitrate of a concentration suitable to give a positive result in a sulfate test		
[MH]	limewater and apparatus to test for carbon dioxide
