
(b) (i) The effect of impact (1) can cause a structure to fail (1). It increases the moment (1) of the applied force. [3]

(ii) Benefit: Quick and easy to build up a structure [2] Drawback: Tend to buckle easily [2]




(d) (i) Moments @ R1

 $7.5/3 = R2 (1) = 2.5 N (1)$
 For equilibrium R1 + R2 = 10 N
 thus R1 = $10 N - 2.5 N = 7.5 N (1)$







(iii) Toggle switch; slider switch

- The resistor RI and capacitor CI act together (1) to create a delay (1) which can be varied according to their values (1). [3]
 - (ii) The transistor acts as a sensitive switch (1) to control the current flow (1) through the bulb (1). [3]
 - (iii) Electrolytic capacitors have polarity (1) and must be connected accordingly (1). Ceramic capacitors are usually small value capacitors and can be connected either way round (1) [3]

- (ii) The resistor is a current limiting device (1) that will protect the LED (1) from overload (1) [3]
- (d) Total Resistance = $V/I = 9/0.001 = 9000 \Omega (1)$

R2 =
$$V2/1 = 2/0.001 = 2000 \Omega (1)$$

Thus R1 + R2 =
$$9000 (1)$$
 and R1 = $9000 - 2000 = 7000 (1)$
