# Instructions for preparing apparatus

www.papaCambridge.com These instructions detail the apparatus, reagents and specimens required by each candidate experiment in this paper. A summary of the questions that will be presented to the candidate included, where appropriate, to allow the teacher to test the apparatus appropriately. No access permitted to the question paper in advance of the examination session.

It is assumed that the ordinary apparatus of a science laboratory will be available, including a supply of purified water (distilled or deionised).

If arrangements are made for different sessions for different groups of candidates, care must be taken to ensure that the different groups of candidates are effectively isolated so that no information passes between them.

### All specimens should carry only the code letters and numbers as indicated and their identity should not be revealed to the candidates.

Supervisors should ensure that all specimens have the correct identity attached to the specimen and that these are **not** removed during the examination.

If a candidate breaks any of the apparatus, or loses any of the material supplied, the matter should be rectified and a note made in the Supervisor's Report.

Supervisors are advised to remind candidates that all substances in the examination should be treated with caution. Only those tests described in the Question Paper should be attempted. Pipette fillers and safety goggles should be used where necessary.

In accordance with COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant.

<b>C</b> = corrosive substance	<b>F</b> = highly flammable substance
H = harmful or irritating substance	<b>O</b> = oxidising substance
T = toxic substance	<b>N</b> = harmful to the environment


The attention of Centres is drawn to any local regulations relating to safety, first-aid and disposal of chemicals.

# For Question 1

Each candidate will require:

- www.papacambridge.com (i) two similar dicotyledonous potted plants labelled plant A and plant B, e.g. geranium. up as shown in Fig. 1.1, on page 5.
- Plant **A** should have a chemical placed in the bag to absorb any carbon dioxide. Soda lime could be used. [H]

Plant B requires no chemicals (to absorb carbon dioxide).

The plants should be well watered, and then destarched by being left in the dark for 48 hours. Their leaves should be partly covered (top and bottom) with black paper, as shown in Fig. 1.1. They should be left under bright lights for 2 days before the examination. Candidates will use one leaf from each plant, so the same plants can be shared between several candidates.

- (ii) Bunsen burner and a means to light it
- (iii) heatproof mat
- (iv) tripod
- (v) gauze
- (vi) 500 cm<sup>3</sup> beaker and water to half fill it or access to a very hot (simmering) water bath
- (vii) tweezers

[F][H] (viii) 30 cm<sup>3</sup> alcohol (ethanol), labelled alcohol

- (ix) two large hard glass test-tubes (150 x 25 mm)
- (x) container (or large beaker) for the safe disposal of the alcohol, labelled waste alcohol
- (xi) iodine solution in a dropping bottle, labelled iodine
- (xii) 2 white tiles
- (xiii) permanent marker pen.




# For Question 2

Each candidate will require:

- (i) a clamp, boss and stand
- (ii) a pendulum bob attached to approximately 70 cm of thread
- (iii) a split cork or similar to hold the thread in the clamp
- (iv) a metre rule with a millimetre scale
- (v) a stopwatch.
- **Note:** The simple pendulum is to be set up for the candidates with the point of support **exactly** 55.0 cm above the level of the bench, as shown in Fig. 2.1.



# For Question 3

Each candidate will require:

- www.papacambridge.com (i) about 10 cm<sup>3</sup> of approximately 0.4 mol dm<sup>-3</sup> sodium hydroxide, labelled A [H]
  - (ii) about  $10 \text{ cm}^3$  of approximately  $1.0 \text{ mol dm}^{-3}$  ammonia solution, labelled **B**
- [H] (iii) about  $10 \text{ cm}^3$  of approximately  $1.0 \text{ mol dm}^{-3}$  hydrochloric acid, labelled **C** 
  - (iv) 3 test-tubes, (125 x 15 mm) with means of supporting them
  - (v) Universal Indicator solution with dropper, labelled Universal Indicator
- **[N] [H] (vi)** about 10 cm<sup>3</sup> aqueous silver nitrate, approximately 0.05 mol dm<sup>-3</sup>, labelled silver nitrate
  - (vii) about 10 cm<sup>3</sup> aqueous copper(II) sulfate, approximately 0.5 mol dm<sup>-3</sup>, labelled copper sulfate
  - (viii) distilled water in a washbottle, labelled distilled water
  - (ix) 500 cm<sup>3</sup> beaker or container, labelled waste
  - (x) permanent marker pen
  - (xi) 5 teat pipettes.

Spare materials and equipment should be available and can be provided without penalty. Candidates should be made aware of this.

#### Information required from the Supervisor:

The Supervisor is asked to carry out the experiments and to enter the results on a spare copy of the examination paper, clearly marked 'Supervisor's Results' and showing the Centre number. This should be done, out of sight of the candidates, using the same solutions, reagents, specimens and apparatus as the candidates.

A copy of the 'Supervisor's Results' should be returned with each packet of scripts. Failure to do so may cause the candidates to be penalised.
