

General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
 This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiments in Questions 1 and 2 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

Apparatus

The apparatus listed must be provided to each candidate.

Question 1

- 1 x plastic cup (expanded polystyrene/foamed plastic) which will fit into a 250 cm³ beaker
- $1 \times 250 \, \text{cm}^3 \, \text{beaker}$
- $1 \times 25 \, \text{cm}^3$ measuring cylinder
- 1 × 10 cm³ measuring cylinder
- $1 \times 25 \, \text{cm}^3$ pipette
- 1 × pipette filler
- $1 \times 50 \, \text{cm}^3 \text{ burette}$
- 1 × stand
- 1 × burette clamp
- 1 × funnel for filling burette
- 1 \times stirring thermometer, –10 °C to +110 °C with 1 °C graduations access to distilled water

Question 2

- 2 × test-tubes
- 1 × test-tube rack
- 4 × boiling tubes
- 1 x boiling tube holder suitable for heating
- 1 × 10 cm³ measuring cylinder
- 1 × spatula
- 1 × wash bottle containing distilled water
- 1 × Bunsen burner and means to light it

means to support 4 boiling tubes

a supply of teat/dropping pipettes

1 × beaker (for washing teat/dropping pipettes)

paper towels

red and blue litmus papers

wooden splints

apparatus normally used in the centre to test for carbon dioxide with limewater

Candidates are expected to rinse and reuse test-tubes and boiling tubes where necessary. Additional tubes should be available.

Warning: small amounts of NH₃ [C][T][N], which can cause respiratory distress in some people, may be produced. The laboratory must be well ventilated.
