# AS/A Level Art and Design: **Unendorsed**

(Available for teaching from September 2008)

The unendorsed route through this specification gives candidates a rounded exposure to different aspects of art and design, allowing them to display their abilities in a variety of artistic disciplines and demonstrate their understanding of these contexts.



# What are the benefits to me and my students of delivering this OCR specification?

- Supports breadth and depth of study by building on the strengths of the previous specification.
- It cuts the assessment burden on candidates with just two units at AS and two units at A2 in each case one is coursework, one is examined.
- With both endorsed and unendorsed routes on offer, candidates can take more than one as a qualification.

- This new specification is excellent preparation for candidates wishing to progress to art college or to engage in careers involving the visual arts, with new technology involved where appropriate.

	• Candidates must produce and submit practical work that shows evidence of working from at least two of the endorsed areas.	
Controlled Assignment	Candidates select one starting point from an early release question paper.	Mandatory
	• Candidates must be given a minimum of 3 weeks in which to plan and prepare.	
	• Candidates are then given 5 hours of controlled time to work on developing their idea into a realisation/outcome.

Personal Investigation	Candidates submit one major project which has a personal significance.	Mandatory
	• The investigation includes a related personal study that must be between 1000 – 3000 words.

Controlled	Candidates select one starting point from an early release question paper.	Mandatory
	• Candidates must be given a minimum of 3 weeks in which to plan and prepare.	
Assignment	<ul> <li>In 15 hours of controlled time, candidates work to plan and then realise ideas into a final outcome.</li> </ul>	
	Candidates can choose a specific endorsement route to follow for this unit.
