#### **SCORIS**

#### **MARKING**

- Work crossed out:
  - a. where a candidate crosses out an answer and provides an alternative response, the crossed out response is not marked and gains no marks
  - b. if a candidate crosses out an answer to a whole question and makes no second attempt, and if the inclusion of the answer does not cause a rubric infringement, the assessor should attempt to mark the crossed out answer and award marks appropriately.

This Mark Scheme is a working document; it is not exhaustive; it does not provide 'correct' answers. The Mark Scheme can only provide 'best guesses' about how the question will work out, and it is subject to revision after we have looked at a wide range of scripts.

The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co–ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co–ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

#### INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- The specific task–related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. It is hoped that candidates will respond to questions in a variety of ways. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	Generic mark scheme for Question 1(a) and Question 2(a): Which of the following? [10]
Level 6 9–10 marks	Both factors are thoroughly analysed and evaluated using accurate and detailed knowledge and understanding of key features of the period, in order to reach a developed and substantiated judgement in relation to the question.
<b>Level 5</b> 7–8 marks	Both factors are analysed and evaluated using generally accurate and detailed knowledge and understanding of key features of the period, in order to reach a substantiated judgement in relation to the question.
Level 4 5–6 marks	Both factors are analysed and evaluated using relevant knowledge and understanding of key features of the period, however treatment of factors may be un-even with analysis and evaluation of one of the two being only partial. Analysis and evaluation is used to support a reasonable judgement in relation to the question.
Level 3 3–4 marks	Both factors are analysed and evaluated in a partial way, using some relevant knowledge of key features of the period, in order to make a basic judgement in relation to the question.
<b>Level 2</b> 2 marks	Limited and generalised knowledge of the period is used to attempt a limited analysis or evaluation of both factors, and this is linked to a very simplistic judgement.
Level 1 1 mark	Very limited and generalised knowledge of the period is used to attempt a very limited analysis or evaluation of one of the factors. The other factor is either not considered or there is very limited information or description of the factor with no attempt to use this knowledge. If there is a judgement, this takes the form of assertion.
0 marks	Nothing of any relevance to the factors.

	Generic mark scheme for Question 1(b) and Question 2(b): Essay [20]
Level 6 17–20 marks	There is a consistent focus on the question throughout the answer. Accurate and detailed knowledge and understanding is demonstrated throughout the answer and is consistently evaluated and analysed in order to reach substantiated, developed and sustained judgements.  There is a well-developed and sustained line of reasoning which is coherent and logically structured. The information presented is entirely relevant and substantiated.
Level 5 13–16 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed.  There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 10–12 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made.  There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3 7–9 marks	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and analysed in parts of the answer, but in places knowledge is imparted rather than being used. The analysis is appropriately linked to the judgements made, though the way in which it supports the judgements may not always be made explicit.  The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
Level 2 4–6 marks	The focus is more on the topic than the specific demands of the question. Knowledge and understanding is limited and not well used, with only limited evaluation and analysis, which is only sometimes linked appropriately to the judgements made.  The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.
Level 1 1–3 marks	The answer relates to the topic but not the specific question. The answer contains only very limited relevant knowledge which is evaluated and analysed in a very limited way. Judgements are unsupported and are not linked to analysis.  Relevant knowledge is limited, generalised and poorly used; attempts at argument are no more than assertion.  Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.  No evidence of understanding and no demonstration of any relevant knowledge.

However, the ease with which Patrick Gordon and troops loyal to the Tsar defeated them in 1698 and their lack of support when they were being massacred may indicate that they had had their day.</li> <li>In dealing with Tsarevitch Alexis, answers might see his personal weaknesses endangering the succession and continuation of strong government.</li> <li>Answers might consider the danger that Alexis would be the focus for those who resented the reforms.</li> <li>Answers might consider the torture and death of Alexis as weakening Peter's reputation and revealing his barbarity.</li> </ul>	10	<ul> <li>No set answer is expected</li> <li>Judgement must be supported by relevant and accurate material.</li> <li>Only credit material relevant to the threat to Peter.</li> <li>Answers may deal with each factor in turn, then compare them to reach a judgement, or make take a continually comparative approach. 1 (b)*	<ul> <li>How far did Tsars Alexis and Feodor reform and modernise Russia in the period from 1646 to1682?</li> <li>In arguing that there was modernisation and reform, answers might consider Alexis' abolition of the terem and his promotion of female education.</li> <li>Answers might consider modernisation of religious practice and greater state control over the Church in keeping more with modern monarchical practice in Europe.</li> <li>Answers might consider increasing number of foreigners brought into Russia as craftsmen and the development of trade links and the shelter of western refugees.</li> <li>Answers might consider the Tsars' use of advisers who believed in contact with the West and their adoption of some western customs.</li> <li>Answers might consider Feodor's support for Golitsyn's abolition of the Book of Ranks.</li> <li>In arguing that modernisation and reform were relatively limited, answers might consider the new law code of 1649 and the legal recognition of serfdom.</li> <li>Answers might contrast the much more extensive modernisation of Peter and point to the powers of the boyars which remained, and traditional elements like the Streltsi.</li> <li>Answers might consider the brutal suppression of Stenka Razin's rebellion.</li> <li>Answers might suggest that the repression of the old believers indicated westernisation was limited.</li> </ul>	20	<ul> <li>No set answer is expected.</li> <li>At higher levels candidates will focus on 'how far', but at Level 4 may simply list attempts to modernise.</li> <li>At Level 5 and above there will be judgement as to the relative importance of the extent of the threat.</li> <li>At higher levels candidates might establish criteria against which to judge the threat.</li> <li>To be valid judgements, claims must be supported by relevant and accurate material.
