Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- 1 The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- 2 The specific task-related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- 3 Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	AO1: Demonstrate, organise and communicate knowledge and understanding to analyse and evaluate the key features related to the periods studied, making substantiated judgements and exploring concepts, as relevant, of cause, consequence, change, continuity, similarity, difference and significance.
	Generic mark scheme for Section A, Questions 1 and 2: Essay [30]
Level 5 25–30 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed. There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 19–24 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made. There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3 13–18 marks	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and analysed in parts of the answer, but in places knowledge is imparted rather than being used. The analysis is appropriately linked to the judgements made, though the way in which it supports the judgements may not always be made explicit. The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
Level 2 7–12 marks	The focus is more on the topic than the specific demands of the question. Knowledge and understanding is limited and not well used, with only limited evaluation and analysis, which is only sometimes linked appropriately to the judgements made. The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.
Level 1 1–6 marks	The answer relates to the topic but not the specific question. The answer contains only very limited relevant knowledge which is evaluated and analysed in a very limited way. Judgements are unsupported and are not linked to analysis. Relevant knowledge is limited, generalised and poorly used; attempts at argument are no more than assertion. Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.

	Generic mark scheme for Section B, Question 3: Interpretation [20]
Level 5 17–20 marks	The answer has a very good analysis of the interpretation. It uses detailed and relevant knowledge of the historical context and shows thorough understanding of the wider historical debate, in the form of detailed examination of other interpretations, in order to produce a well-supported evaluation of both the strengths and weaknesses of the given interpretation.
Level 4 13–16 marks	The answer has a good analysis of the interpretation. It uses relevant knowledge of the historical context and good understanding of the wider historical debate, in the form of examination of other interpretations, in order to produce a supported evaluation of both the strengths and weaknesses of the given interpretation.
Level 3 9–12 marks	The answer has a partial analysis of the interpretation. It uses some relevant knowledge of the historical context and shows partial understanding of the wider historical debate, in the form of reference to other interpretations, in order to evaluate the strengths and weaknesses of the given interpretation. The evaluation may be un-even with only limited treatment of either limitations or strengths, but both will be addressed.
Level 2 5–8 marks	The answer has a limited analysis of the interpretation. It uses generalised knowledge of the historical context and shows limited understanding of the wider historical debate, in the form of generalised reference to other interpretations, in order to produce a limited evaluation of the given interpretation. The evaluation may deal with either strengths or limitations in a very superficial way, or may only address limitations or strengths.
Level 1 1–4 marks	The answer has a very limited analysis of the interpretation which may be descriptive and relate more to the topic area than the detail of the interpretation. It uses very limited and generalised knowledge of the historical context and shows very limited or no understanding of the wider historical debate, with reference to other interpretations being implicit or lacking, in order to produce a very simplistic, asserted evaluation of the given interpretation.

1*	 Assess the reasons for the rise of the Umayyad Empire. In arguing that it was long term factors, answers might consider the rule of Uthman ibn Affan who revived Umayyad power. Answers might consider Uthman's placing of members of the clan in positions of power as being important in their rise to power. Answers might consider the importance and success of Muawiyah as governor of Syria and his building up of a disciplined army. In arguing that it was short term factors, answers might consider the assassination of Ali ibn. Ali Talib in 661 which left Muawiyah as the strongman of the Muslim community. Answers might argue that the agreements made by Muawiyah with other provinces aided the rise to power. Answers might consider the struggles of Ali's last years and his having to agree to arbitration over the issues that divided him and Muawiyah. 	30	 No set answer is expected. At Level 5 there will be judgement as to the relative importance of the reasons. At level 5 answers might establish criteria against which to judge the relative importance of the reasons. To be valid, judgements must be supported by relevant and accurate material. If not, they are assertions. Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.
2*	 'Abu Bakr's victory in the Ridda Wars was mainly due to strength of his forces.' How far do you agree? In arguing that it was the strength of Bakr's forces, answers might consider the size of the force raised. Answers might consider the importance of the loyalty of the people of the Hijaz, city-dwellers and nomads to the umma. 	30	 No set answer is expected. At Level 5 there will be judgement as to the relative importance of the reasons. At level 5 answers might establish criteria against which to judge the relative importance of the reasons. To be valid, judgements must be supported by relevant and accurate material. If not, they are assertions.

	 Answers might consider the unity of the Hijaz. Answers might consider that a number joined the Muslims because of the opportunities offered. In arguing that it was due to the weakness of the opposition, candidates might consider the divisions among the opposition. Answers might consider the lack of religious opposition to Islam. Answers might consider the impact of the collapse of the Persian Empire. In arguing that it was due to other factors, candidates might consider the tactics Bakr used. Answers might consider the importance of negotiations in securing both troops and bloodless resolutions. The historical debate about the rise of Islam centres around the relative importance of 5 key factors: economic, social, political, religious and military. In analysing and evaluating the strengths and limitations of the interpretation, answers might consider that trade rather than general economic factors is quoted, and may consider the focus on Mecca rather than other geographical locations. In analysing and evaluating the strengths of the given interpretation, answers might use knowledge and understanding of: the way ideology reflected changes in Arab society in slavery, property and exchanges 	20	 No set answer is expected. Candidates must use their knowledge and understanding of the historical context and the wider historical debate surrounding the issue to analyse and evaluate the given interpretation. Candidates must refer to at least one other interpretation. The quality of analysis and evaluation of the interpretations should be considered when assigning answers to a level, not the quantity of other interpretations included in the answer. Other interpretations considered as part of evaluation and analysis do not need to be attributed to specific named historians, but they must be recognisable historical interpretations, rather than the candidate's own viewpoint Answers may include more on strengths or more on limitations and there is no requirement for a 50/50 split in the evaluation of both, in line with levels descriptors. Candidates are not required to construct their own interpretation.

	 the new economic environment in which the Meccans found themselves the importance of expansion of trade, particularly international with the Sasanian and Byzantine Empires that the raison d'etre of Mecca was trade, linked to a religious shrine, making religion inseparable from trade the importance of the caravan trade and its control. In analysing the limitations of the given interpretation, answers might use knowledge and understanding of: the personal role of Muhammad the social unrest in Mecca the civil strife in Medina. Other interpretations that might be used in evaluation of the given interpretation are: interpretations focusing on the role of Mohammed and the religious nature of his message interpretations that consider that the regions in question were already familiar with monotheistic religions interpretations that emphasise the importance of political reasons and the role of military victories and diplomatic initiatives.
