

SCORIS

MARKING

Please study this Mark Scheme carefully. The Mark Scheme is an integral part of the process that begins with the setting of the question paper and ends with the awarding of grades. Question papers and Mark Schemes are developed in association with each other so that issues of differentiation and positive achievement can be addressed from the very start.

This Mark Scheme is a working document; it is not exhaustive; it does not provide 'correct' answers. The Mark Scheme can only provide 'best guesses' about how the question will work out, and it is subject to revision after we have looked at a wide range of scripts.

The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co–ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co–ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- The specific task-related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	Generic mark scheme for Section A, Questions 1 and 2: Essay [30]
Level 5 25–30 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed. There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 19–24 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made. There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3 13–18 marks	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and analysed in parts of the answer, but in places knowledge is imparted rather than being used. The analysis is appropriately linked to the judgements made, though the way in which it supports the judgements may not always be made explicit. The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
Level 2 7–12 marks	The focus is more on the topic than the specific demands of the question. Knowledge and understanding is limited and not well used, with only limited evaluation and analysis, which is only sometimes linked appropriately to the judgements made. The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.
Level 1 1–6 marks	The answer relates to the topic but not the specific question. The answer contains only very limited relevant knowledge which is evaluated and analysed in a very limited way. Judgements are unsupported and are not linked to analysis. Relevant knowledge is limited, generalised and poorly used; attempts at argument are no more than assertion. Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.

Level 5 17–20 marks Level 4 13–16 marks	The answer has a very good analysis of the interpretation. It uses detailed and relevant knowledge of the historical context and shows thorough understanding of the wider historical debate, in the form of detailed examination of other interpretations, in order to produce a well-supported evaluation of both the strengths and weaknesses of the given interpretation. The answer has a good analysis of the interpretation. It uses relevant knowledge of the historical context and good understanding of the wider historical debate, in the form of examination of other interpretations, in order to produce a supported evaluation of both the strengths and weaknesses of the given interpretation.
Level 3 9–12 marks	The answer has a partial analysis of the interpretation. It uses some relevant knowledge of the historical context and shows partial understanding of the wider historical debate, in the form of reference to other interpretations, in order to evaluate the strengths and weaknesses of the given interpretation. The evaluation may be un-even with only limited treatment of either limitations or strengths, but both will be addressed.
Level 2 5–8 marks	The answer has a limited analysis of the interpretation. It uses generalised knowledge of the historical context and shows limited understanding of the wider historical debate, in the form of generalised reference to other interpretations, in order to produce a limited evaluation of the given interpretation. The evaluation may deal with either strengths or limitations in a very superficial way, or may only address limitations or strengths.
Level 1 1–4 marks	The answer has a very limited analysis of the interpretation which may be descriptive and relate more to the topic area than the detail of the interpretation. It uses very limited and generalised knowledge of the historical context and shows very limited or no understanding of the wider historical debate, with reference to other interpretations being implicit or lacking, in order to produce a very simplistic, asserted evaluation of the given interpretation.

1*	 Assess the reasons why Saladin was able to conquer Jerusalem in 1187. Answers need to identify, explain and assess a range of reasons. Answers may discuss some of the specific reasons for the defeat of Jerusalem's forces at Hattin, drawing out Jerusalem's mistakes as well as Saladin's skills as a general, but such discussion needs to be set in the broader context of why a defeat of Jerusalem was likely in the 1180s. Answers may discuss some of the following: how Saladin operated form a strong power base and his consolidation of power in Egypt and Syria in the 1170s and early 1180s. Answers may discuss the use of the concept of jihad to unite Muslims in an attack on the Crusader States in the mid-1180s (and in 1187 in particular). Answers may discuss the succession crisis and the factional in-fighting that beleaguered the Kingdom of Jerusalem as Baldwin IV's leprosy progressed to his death. Answers may discuss the actions of Reynald of Chatillon in provoking Saladin. Candidates may discuss Saladin's reduction of crusader castles and taking ports and strongholds and the taking of Jerusalem. 	30	 No set answer is expected. At Level 5 there will be judgement as to the relative importance of the reasons. At level 5 answers might establish criteria against which to judge the relative importance of the reasons. To be valid, judgements must be supported by relevant and accurate material. If not, they are assertions. Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.

2*	 Candidates may well argue that it was a combination of Saladin's strength and Crusader weakness that accounts for his successes. Assess the reasons for the failure of the Second Crusade (1147–1149). 	30	 No set answer is expected. At Level 5 there will be judgement as to the relative importance of the reasons.
	 Answers might discuss a lack of a clear and unified command structure (e.g. the separate expeditions of Louis VII and Conrad III). Answers might consider internal divisions and differences between settlers in the Levant and European Crusaders and the impact of the internal politics of the Crusader states. Answers might discuss a lack of a clear aims (and the diversion of potential resources against the Wends in eastern Europe and in the Reconquista in Spain and Portugal). Answers might consider the poor choice of routes and strategic and tactical errors (both in Anatolia and Outremer). Answers might consider the role of Emperor Manuel I and a lack of Byzantine help. Answers might consider the strengths and relative unity of their opponents (both in Anatolia and the threat posed by Nur ed Din). Answers might discuss the decision not to attack Edessa or Aleppo and the decision to attack Damascus. Answers might consider the exaggerated expectations of the crusaders. 		 At level 5 answers might establish criteria against which to judge the relative importance of the reasons. To be valid, judgements must be supported by relevant and accurate material. If not, they are assertions. Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.

From: Jonathan Phillips, <i>The Crusades 1095-1197</i> , 2002 Evaluate the strengths and limitations of this interpretation, making reference to other interpretations that you have studied. • The historical debate about the reasons for the First Crusade centres on the relative importance of five key factors: religious, political, economic, social and military. • In analysing and evaluating the strengths and limitations of the interpretation, answers might consider that political and economic factors rather than just religious factors were important. They may consider the focus on the Levant and Jerusalem rather than other geographical locations. • In analysing and evaluating the strengths of the given interpretation, answers might use knowledge and understanding of: • the importance of spiritual issues in peoples' lives at the time	20	 No set answer is expected. Candidates must use their knowledge and understanding of the historical context and the wider historical debate surrounding the issue to analyse and evaluate the given interpretation. Candidates must refer to at least one other interpretation. The quality of analysis and evaluation of the interpretations should be considered when assigning answers to a level, not the quantity of other interpretations included in the answer. Other interpretations considered as part of evaluation and analysis do not need to be attributed to specific named historians, but they must be recognisable historical interpretations, rather than the candidate's own viewpoint. Answers may include more on strengths or more on limitations and there is no requirement for a 50/50 split in the evaluation, however for level 5 there should be well-supported evaluation of both and for level 4 supported evaluation of both, in line with levels descriptors. Candidates are not required to construct their own interpretation.

In analysing the limitations of the given interpretation, answers might use knowledge and understanding of: the threat to the Byzantine empire from Turkey the possibility of establishing settlements in the Holy Land (and land acquisition) the chance to acquire booty the importance of family networks and family loyalty the motives of individual crusaders. Other interpretations that might be used in evaluation of the given interpretation are: interpretations focusing on the request from Alexius Comnenus to help protect the Byzantine empire interpretations that emphasise the economic motives of those that went on the First Crusade interpretations that stress the interconnectedness of motives including those not often mentioned such as a need to escape legal proceedings at home.
