The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co–ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co–ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

## INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.

However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

From: Tim Stanley, History Today, Volume: 61 Issue: 3 2011  Evaluate the strengths and limitations of this interpretation, making reference to other interpretations that you have studied.  • The historical debate about the collapse of the Aztec Empire centres around the extent to which it can be attributed to Aztec weaknesses versus the strengths, or luck, of the Spanish Conquistadors, led by Hernan Cortes.  • In analysing and evaluating the strengths and limitations of the interpretation, answers might	Marks 20	<ul> <li>No set answer is expected.</li> <li>Candidates must use their knowledge and understanding of the historical context and the wider historical debate surrounding the issue to analyse and evaluate the given interpretation.</li> <li>Candidates must refer to at least one other interpretation.</li> <li>The quality of analysis and evaluation of the interpretations should be considered when assigning answers to a level, not the quantity of other interpretations included in the answer.</li> <li>Other interpretations considered as part of evaluation and analysis do not need to be attributed to specific named historians, but they must be recognisable historical interpretations, rather than the candidate's own viewpoint.</li> <li>Answers may include more on strengths or more on limitations and there is no requirement for a 50/50 split in the evaluation, however for level 5 there should be well-</li> </ul>

	<ul> <li>the Aztec belief in fate, and the assumption that the Conquistadors were gods, hence their slow reaction against them (nb – this interpretation is debated)</li> <li>the centralisation of all power in the figure of Montezuma, as this left the Aztecs rudderless once he was captured and executed by the Spanish</li> <li>the highly ritualised nature of warfare in Aztec culture, which meant the Aztec army was unsuited to warfare against the Spanish.</li> <li>In analysing the limitations of the given interpretation, answers might use knowledge and understanding of:</li> <li>the outward-facing and tenacious Aztec culture, which saw ongoing resistance against the Spanish after the death of Montezuma; the strategic luring of the Spanish invaders away from the coast to place them in a more vulnerable position</li> <li>the leadership qualities and ruthlessness of Cortes</li> <li>the superior equipment and military strategy of the Spanish, namely the use of firearms, horses and dogs</li> <li>the importance of Spanish alliances with subject peoples of the Aztec empire</li> <li>the importance of disease in critically weakening the Aztec population.</li> </ul>

	Other interpretations that might be used in evaluation of the given interpretation are:		
	<ul> <li>interpretations focusing on the strength, or luck, of the conquistadors and the importance of Cortes' leadership</li> <li>interpretations that consider the critical impact of disease on the indigenous population</li> <li>interpretations which question the prevailing narrative about the Aztec culture and response, for example questioning whether the Aztecs ever believed the conquistadors were gods.</li> </ul>
