The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co–ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co–ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- 1 The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- 2 The specific task-related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- 3 Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

Level 5 25–30 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed.
	There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 19–24 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made.
	There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and

Level 5 17–20 marks	The answer has a very good analysis of the interpretation. It uses detailed and relevant knowledge of the historical context and shows thorough understanding of the wider historical debate, in the form of detailed examination of other interpretations, in order to produce a well-supported evaluation of both the strengths and weaknesses of the given interpretation.
Level 4 13–16 marks	The answer has a good analysis of the interpretation. It uses relevant knowledge of the historical context and good understanding of the wider historical debate, in the form of examination of other interpretations, in order to produce a supported evaluation of both the strengths and weaknesses of the given interpretation.
Level 3 9–12 marks	The answer has a partial analysis of the interpretation. It uses some relevant knowledge of the historical context and shows partial understanding of the wider historical debate, in the form of reference to other interpretations, in order to evaluate the strengths and weaknesses of the given interpretation. The evaluation may be un-even with only limited treatment of either limitations or strengths, but both will be addressed.
Level 2 5–8 marks	The answer has a limited analysis of the interpretation. It uses generalised knowledge of the historical context and shows limited understanding of the wider historical debate, in the form of generalised reference to other interpretations, in order to produce a limited evaluation of the given interpretation. The evaluation may deal with either strengths or limitations in a very superficial way, or may only address limitations or strengths.
Level 1 1–4 marks	The answer has a very limited analysis of the interpretation which may be descriptive and relate more to the topic area than the detail of the interpretation. It uses very limited and generalised knowledge of the historical context and shows very limited or no understanding of the wider historical debate, with reference to other interpretations being implicit or lacking, in order to produce a very simplistic, asserted evaluation of the given interpretation.

1*	 How important were railways in westward expansion? In relation to railways, candidates may argue that railways were both a symptom and a cause of the opening up of the west. The desire to build transcontinental railways came as a result of the pioneers, settlers, miners and cattlemen who had already gone west. However, there is no doubt that the building of railways acted as a huge stimulus to westward expansion and settlement. Candidates may point to the symbiotic relationship with cattle drives and ranches, and the ease of communication it brought, as well as the huge investment and sales of land. Candidates might discuss the significance of the cattle drives from the south (Texas) to railheads such as Abilene, Dodge City and Miles City to enable cattle to be transported on to the populous north east in the 1860s. Such discussion needs to be balanced against discussion of other factors in opening up the West, such as the role of fur-trappers and pioneers (such as those that followed the 'Oregon Trail'). Might consider the stimulus given by Federal-sponsored explorers such as Lewis and Clark, and by expeditionary forces such as Fremont's. Candidates might consider the discoveries of gold and silver that led to various rushes. 	30	 No set answer is expected. 	 In arguing that Lincolns election was the main cause of the Civil War? In arguing that Lincolns election was the main cause of the Civil War, answers might suggest that the election of Lincoln was the event which brought to a head the growing tensions between North and South. Answers might consider that it was Lincoln's election that led to the secession of southern states, the failure of compromise and hence Civil War. Answers might consider Southern fears that Lincoln would abolish slavery and the belief that he was a staunch abolitionist. In arguing it was not the main cause, answers might consider the Kansas Nebraska Act and point to its role in the collapse of the Whigs and the rise of the purely Northern-based Republican Party. Answers might also point to the civil disobedience and near civil war which resulted in the new territory of Kansas. Answers might, however, also point to the fact that the issue was largely resolved by 1858. The historical debate about the causes of sectional tension centres around the extent to which it was slavery which was the ultimate reason for sectional tension, and the extent to which the conflict over slavery was a symptom of tension over other causes such as economic differences, states' rights issues and the influence of radicals. In analysing and evaluating the strengths and limitations of the interpretation, answers might consider the central importance which Cunliffe places on slavery as the origin of both 'sections' and the sectional conflict, whilst also implicitly acknowledging that there may have been other, secondary, causes. 	20	 No set answer is expected. Candidates must use their knowledge and understanding of the historical context and the wider historical debate surrounding the issue to analyse and evaluate the given interpretation. Candidates must refer to at least one other interpretation. The quality of analysis and evaluation of the interpretations should be considered when assigning answers to a level, not the quantity of other interpretations included in the answer. Other interpretations considered as part of evaluation and analysis do not need to be attributed to specific named historians, but they must be recognisable historical interpretations, rather than the candidate's own viewpoint. Answers may include more on strengths or more on limitations and there is no requirement for a 50/50 split in the evaluation, however for level 5 there should be well-supported evaluation of both and for level 4 supported evaluation of both, in line with levels descriptors. Candidates are not required to construct their own interpretation.

	 In analysing and evaluating the strengths of the given interpretation, answers might use knowledge and understanding of: the dependence in the South on plantation agriculture which depended on slavery to be competitive disputes over slavery in the territories the fears in the North about the erosion of the 1820 Compromise and the Fugitive Slave Act the fears in the South about abolitionism and John Brown the rise in cotton and slave prices in the 1850s which encouraged further investment but also protection of the system. In analysing the limitations of the given interpretation, answers might use knowledge and understanding of: the political divisions, with the North more receptive to reform and the South condemning all radicalisms, associating them with abolition the wider aspects of economic conflicts and the tariff the cultural gap between an industrial North and a rural South

Other interpretations that might be used in evaluation of the given interpretation are: interpretations characterising sectional differences, and therefore tensions, as fundamentally economic in nature interpretations emphasising the centrality of debates about States' Rights to sectional tension, with issues over slavery merely being a symptom of that interpretations which argue that the extent of sectional tension in the Antebellum period has been over-exaggerated, and rejects a 'grand narrative' of the causes of the war.
